2021 Chevrolet Tahoe PPV. Vehicle was purchased at and upfitted by Karl Emergency Vehicles in Ankeny Iowa in 2022. The vehicle has Whelen LED emergency lighting package (red/blue/white), Whelen WeCanX siren and light controller with rear traffic advisor, Whelen ARGES LED spotlight, Truck Vault storage system in the rear with magnetic dry erase command board, two full-length drawers, and pull-out table. Havis console, Streamlight Stinger flashlight and charger, and Ranch Hand full-size brush guard. It will also come with 5 key fobs-3 of which are programmed. Vehicle is in excellent mechanical condition and ready for work.

*The vehicle will NOT come with the Harris mobile radio and antenna, Sierra Wireless MG90 router and antenna, Harris portable radio charger, Havis computer mount and docking station, or Streamlight lantern. Agency badging/markings will be removed from vehicle prior to sale.

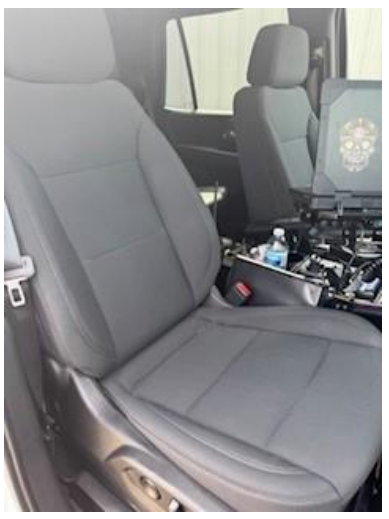
