## ORDINANCE NO. 7

TITLE: Poweshiek County Precinct Boundaries

PURPOSE: An ordinance establishing precincts to be used for elections held in Poweshiek County to be effective January 15, 2002 until the completion of the next federal decennial census.

## **Election Precinct Boundaries**

Precinct No. 2 – All of the area lying within the Township boundaries of Bear Creek Township, including the city of Brooklyn, shall constitute the Bear Creek precinct. According to the 2000 census figures, this precinct is comprised of 1,709 residents. The polling place for this precinct is Brooklyn City Office, Brooklyn, IA.

Precinct No. 3 – All of the area lying within the Township boundaries of Chester Township, shall constitute the Chester precinct. According to the 2000 census figures, this precinct is comprised of 292 residents. The polling place for this precinct is Chester Royal Grange, Grinnell, IA.

Precinct No. 4 - All of the area lying within the Township boundaries of Deep River Township, including the city of Deep River, shall constitute the Deep River precinct. According to the 2000 census figures, this precinct is comprised of 497 residents. The polling place for this precinct is Deep River Community Center, Deep River, IA.

Precinct No. 5 – All of the area lying within the Township boundaries of Grant Township, excluding the city of Grinnell, shall constitute the Grant precinct. According to the 2000 census figures, this precinct is comprised of 491 residents. The polling place for this precinct is 4-H Building, Grinnell, IA.

Precinct No. 6 – All of the area of the city of Grinnell, lying north and east of a line beginning on the centerline of Sixth Avenue at the east city limits and extending along the centerline of Sixth Avenue to the centerline of Penrose Street, then north along the centerline of Penrose Street to Eighth Avenue, then west along the centerline of Eighth Avenue to Summer Street, then south along the centerline of Summer Street to Sixth Avenue, Then west along the centerline of Sixth Avenue to Main Street, then north along the centerline of Main Street from Sixth Avenue to Eleventh Avenue, then west along the centerline of Eleventh Avenue to West Street, then north along the centerline of West Street to the north city limits, shall constitute First Ward Precinct. According to the 2000 census figures, this precinct is comprised of 2,274 residents. The Polling place for this precinct is Fairview Elementary School, Grinnell, IA.

Precinct No. 7 – All of the area of the city of Grinnell, lying north and west of a line beginning on the centerline of Sixth Avenue at the west city limits and extending east along the centerline of Sixth Avenue to the centerline of Prairie Street, then south along the centerline of Prairie Street to

Fifth Avenue, then east along the centerline of Fifth Avenue to Pearl Street, then north along the centerline of Pearl Street to Sixth Avenue then east along the centerline of Sixth Avenue to Main Street, then north along the centerline of Main Street from Sixth Avenue to Eleventh Avenue, then west along the center line of Eleventh Avenue to West Street, then north along the centerline of West Street to the north city limits, shall constitute Second Ward Precinct. According to the 2000 census figures, this precinct is comprised of 2,287 residents. The Polling Place for this precinct is Bailey Park Elementary School, Grinnell, IA.

Precinct No. 8 — All of the area of the city of Grinnell, which is encompassed by a line which begins at the intersection of the centerline of Sixth Avenue and the west city limits, and then extends east along the centerline of Sixth Avenue to the centerline of Prairie Street, then south along the centerline of Prairie Street to Fifth Avenue, then east along the centerline of Fifth Avenue to Pearl Street, then north along the centerline of Pearl Street to Sixth Avenue, then east along the centerline of Sixth Avenue to East Street, then south along the centerline of East Street to Fourth Avenue, then west along the centerline of Fourth Avenue to Broad Street, then south along the centerline of Broad Street to Third Avenue, then east along the centerline of Third Avenue to the west right-of-way line of the Chicago Northwestern Railroad, then south along such right-of-way line to the south city limits, then west and north along the city limits to the point of beginning, shall constitute Third Ward Precinct. According to the 2000 census figures, this precinct is comprised of 2,249 residents. The Polling Place for this precinct is Grinnell Community Center, Grinnell, IA.

Precinct No. 9 – All of the area of the city of Grinnell, lying south of the First Ward boundaries and east of the Third Ward boundaries, shall constitute Fourth Ward Precinct. According to the 2000 census figures, this precinct is comprised of 2,295 residents. The Polling Place for this precinct is Veterans Memorial Building, Grinnell, IA.

Precinct No. 10 – All of the area lying within the Township boundaries of Jackson Township, excluding the city of Montezuma, IA shall constitute Jackson Township precinct. According to the 2000 census figures, this precinct is comprised of 327 residents. The Polling Place for this precinct is Poweshiek County Extension Office, Montezuma, IA.

Precinct No. 11 – All of the area lying within the Township boundaries of Jefferson Township, including the city of Hartwick, IA shall constitute Jefferson Township precinct. According to the 2000 census figures, this precinct is comprised of 317 residents. The Polling Place for this precinct is Community Center, Hartwick, IA.

Precinct No. 12 – All of the area lying within the Township boundaries of Lincoln Township, including the city of Guernsey, IA shall constitute Lincoln Township precinct. According to the 2000 census figures, this precinct is comprised of 268 residents. The Polling Place for this precinct is Guernsey Methodist Church, Guernsey, IA.

Precinct No. 13 – All of the area lying within the Township boundaries of Madison Township, shall constitute Madison Township precinct. According to the 2000 census figures, this precinct is comprised of 717 residents. The Polling Place for this precinct is Holiday Lake Rental Shop, located at Holiday Lake, Brooklyn, IA.

Precinct No. 14 – All of the area lying within the Township boundaries of Malcom Township, including the city of Malcom, IA, shall constitute Malcom Township precinct. According to the 2000 census figures, this precinct is comprised of 646 residents. The Polling Place for this precinct

is Malcom Auditorium, Malcom, IA.

Precinct No. 15 – All of the area lying within the city limits of Montezuma, IA shall constitute Montezuma precinct. According to the 2000 census figures, this precinct is comprised of 1,440 residents. The Polling Place for this precinct is Montezuma Memorial Hall, Montezuma, IA.

Precinct No. 16 – All of the area lying within the Township boundaries of Pleasant Township, shall constitute Pleasant Township precinct. According to the 2000 census figures, this precinct is comprised of 332 residents. The Polling Place for this precinct is Pleasant Township Hall, Ewart, IA.

Precinct No. 17 – All of the area lying within the Township boundaries of Scott Township, shall constitute Scott Township precinct. According to the 2000 census figures, this precinct is comprised of 272 residents. The Polling Place for this precinct is Scott Township Hall, Montezuma, IA.

Precinct No. 18 – All of the area lying within the Township boundaries of Sheridan Township, shall constitute Sheridan Township precinct. According to the 2000 census figures, this precinct is comprised of 255 residents. The Polling Place for this precinct is Scale House, Poweshiek County Landfill, Malcom, IA.

Precinct No. 19 – All of the area lying within the Township boundaries of Sugar Creek Township, including the city of Searsboro, shall constitute Sugar Creek Township precinct. According to the 2000 census figures, this precinct is comprised of 440 residents. The Polling Place for this precinct is Searsboro Community Center, Searsboro, IA.

Precinct No. 20 – All of the area lying within the Township boundaries of Union Township, shall constitute Union Township precinct. According to the 2000 census figures, this precinct is comprised of 822 residents. The Polling Place for this precinct is Foster Center, Montezuma, IA.

Precinct No. 21 – All of the area lying within the Township boundaries of Warren Township, including the city of Victor which lies within Poweshiek County, shall constitute Warren Township precinct. According to the 2000 census figures, this precinct is comprised of 451 residents. The Polling Place for this precinct is Victor Fire Station, Victor, IA.

Precinct No. 22 – All of the area lying within the Township boundaries of Washington Township, shall constitute Washington Township precinct. According to the 2000 census figures, this precinct is comprised of 434 residents. The Polling Place for this precinct is Washington Township Hall, Grinnell, IA.
