

Ordinance No. 9

TITLE: AN ORDINANCE ADOPTING THE "CODE OF ORDINANCES OF POWESHIEK COUNTY, IOWA 2002"

Be it enacted by the Poweshiek County Board of Supervisors that:

SECTION 1. Pursuant to published notice and following public hearing on the 17th day of June, 2002 so required by Section 331.302, Subsection 9, there is hereby adopted by Poweshiek County, Iowa the "CODE OF ORDINANCES OF POWESHIEK COUNTY, IOWA 2002."

SECTION 2. All of the provisions of the "CODE OF ORDINANCES OF POWESHIEK COUNTY, IOWA 2002" shall be in force and effect on and after the effective date of this ordinance.

SECTION 3. The following ordinances, passed subsequent to the preparation of this code but prior to adoption of this code, are hereby adopted and made a part of this code. Said ordinances shall be codified and incorporated in published copies of this code as supplements thereto following adoption of this ordinance. The ordinances are stated herein by number and subject matter and by the authority of the Poweshiek County Board of Supervisors comprise the Poweshiek County Code of Ordinances 2002 :




SECTION 6. This ordinance shall be in full force and effect from and after the publication of this ordinance, as required by law.


