**RESOLUTION #2023-1
RESOLUTION FOR ESTABLISHING A SPEED LIMIT**

WHEREAS the Board of Supervisors is empowered under authority of Iowa Code Sections 321.255 and 321.285 to determine the speed limit of any secondary road is greater than is reasonable and proper under the conditions existing, and may determine and declare a reasonable and proper speed limit, and

WHEREAS the current closure of F62 between 18th Street and 35th Street for the replacement of a bridge on F62 has caused increased traffic on rock roads in this area,

THEREFORE, BE IT RESOLVED that the speed limit is established effective immediately and terminating upon the reopening of F62 between 18th Street and 35th Street, and appropriate signs shall be erected at the location described as follows:

- 35 mph on E 160th Street commencing at F62 and proceeding north to 490th Avenue.
- 35 mph on 490th Avenue commencing at E 160th Street and proceeding east to IA146.
- 35 mph on 515th Avenue commencing at the Jasper/Poweshiek County line and proceeding east to 35th Street.
- 35 mph on 35th Street commencing at 515th Avenue and proceeding north to F62.

9:00 a.m. Board opened sealed bids for baling of approximately 50 acres of grass hay located at the landfill site. Bids received were:

- Cameron Fisk \$8 per ton
- Murlin McCain \$45.35 per ton

Moved by Roudabush, 2nd by Doty to accept bid from Murlin McCain for \$45.35 per ton. Hay must be mowed by September 15, 2022 and removed from site within 15 days of the baling with payment in full within 60 days of the start of harvest. 3 ayes. Motion carried.

9:05 a.m. Lyle Brehm, Engineer joined the meeting.

9:06 a.m. Dianna Longhenry, Recorder joined the meeting.

Brehm updated the board on bridge projects on F62 and Diamond Trail Road and discussed speed limits on the rock roads established for the detours.

Longhenry discussed with the board the new UTV law passed by State of Iowa and the current county ordinance and inquired if the board had reviewed and would be making any changes to the county ordinance. Longhenry stated she has been receiving many inquiries on the new law and effects with county ordinance. Auditor Eilander stated she reached out to the County Attorney Klaver and he stated some of the ordinance is invalid and some would survive the new statute. For instance, the ordinance's restriction on time of day the UTV could be used and the minimum age requirement is no longer valid. The state statute would take precedence. Any other section that does not conflict with state statute is still good due to the severability clause in Section 8 of the ordinance. The terms of the ordinance state the ordinance shall be reviewed within one year of its passage so the board may address the issues at that time. The ordinance was passed July 22, 2021, so review of the ordinance will be placed on the board's agenda in the coming week.

Board received a change order of original equipment detail for siren sites as sold with system via contract. Change order reflects siren changes at Montezuma, Grinnell, Lake Ponderosa and Brooklyn in amount of \$110,889. Brian Paul, EMA Director applied for and received a grant toward the cost of the siren upgrades. Paul had previously explained that with the federal and state grant funds received, this change order would cost the county approximately \$38,780. Moved by Roudabush, 2nd by Doty to approve change order. 3 ayes. Motion carried.

Board placed call to Iowa Utilities Board to follow up on an article Dawley read in the Cedar Rapids Gazette that referenced Navigator pulling out of Poweshiek County. It was confirmed by Iowa Utilities Board that Navigator is no longer going through Poweshiek County with pipeline. Dawley also inquired if Wolf would be going through the

county with a pipeline. Utilities Board indicated that Wolf has filed a request for an information meeting as of this date and the map provided does not show pipeline going through Poweshiek County.
