Klaver feels his legal assistant and office assistant are behind in wages and this request for an extra \$1 per hour would help to get them more in line with like positions. Board considered Klaver's request and stated they would allow an extra \$4,278 for wages/benefits to the county attorney budget and advised Klaver he could make the decision on distribution among employees.
