9:00 a.m. Tylor Nelson, Conservation Director met with board for monthly meeting.

Board reviewed a wage study from Mahaska County that showed employees current wages and a proposed increase.

9:30 a.m. Ashley Fallis, Allie Girvan, Alyssa Sutherland, Assessor's Office joined the meeting.

9:43 a.m. Mike Mahaffey joined the meeting.

Mahaffey wanted to get some history of the relationship between extension council and fair board. Mahaffey has agreed to work with each party to see if an agreement may be reached regarding duties of each party during the county fair. The board just wants to see everyone work together for benefits of the kids and stated they are willing to provide appropriation to the fair but wants to see that working relationship.

10:10 a.m. Angie Rudd, Megan Tindle, Jennifer Anderson, Sierra Maschmann, Jennifer Norris, Kay Latcham, Jessica Hutchcraft & Sandy Ross, Treasurer's Office; Jodi Meyer & Lora Wyckoff, Recorder's Office; Laura Tish, Auditor's Office joined the meeting.

Discussion with employees regarding FY25 wages for non-contract employees. Dawley stated the board gave a bigger increase last year to try and get wages more in line with other like positions. The board, realizing some employees may be paid less than others, provided departments with an extra allocation in their budget to utilize how they see best for wages of employees in their department. Dawley stated if an employee has a change in job position by moving up and taking on more duties, that employee could receive a pay increase. There is a range set for each job position, and it would be up to the department head to propose this increase for the reason of different positions with different duties. The department head will bring the information relating to the pay increase to the board for approval.

Ross asked if the job change happened mid-year, can there be an adjustment in pay. Board stated if the job is changing and the duties are changing, then the department head may request to change the wages mid-year due to those reasons.

Dawley stated the board is pretty set on going with a \$.75 per hour wage increase for non-contract employees. Roudabush stated the intent of the \$.75 per hour wage increase was to get some of the lower paid employees up a bigger percentage than the higher paid employees. Dawley stated it would be great to provide big raises, but the board needs to maintain the county budget and look at taxation as well as what the state is doing in legislation that affects funding sources for local government and how a lot of these funding sources have been cut by the state.

Ross stated she is working on updating the job descriptions to reflect current positions within her department.

Board stated the non-contract employees will receive a \$.75 per hour wage increase. Board further stated that the IT director requested a 6% increase in wages and the board agreed to award a 5% increase. When the IT director was hired, he was hired to perform IT duties within the courthouse. Since then, he has taken on IT duties at sheriff's office and conservation. Due to the increase in duties, the board felt it appropriate to award this increase for FY25.

Board discussed Pow I-80 funding and services and is still reaching out for more information and will follow up discussion at a future board meeting.
