Roll Call: Supervisors – Jeff Tindle, Jason Roudabush, and Diana Dawley. Auditor's Office Missy Eilander, Zoning Administrator J.D. Griffith, and Scott Strong.

At 9:02 AM Jason made a motion to open Public Hearing, Jeff second, all in favor, motion carried.

J.D. Griffith stated the Zoning Commission met on August 20th 2024. The Zoning Commission voted 6-0 in favor of recommending approval, All members thought it was a good spot for a house, and no opposition was heard from the letters sent to neighboring property owners.

Zach & Carissa Willard are requesting a change in Zoning from Agriculture to Residential for the purpose of building a house.
