The Poweshiek County Board of Supervisors met in regular session at 8:30 a.m. Members present: Jacki Bolen, Jason Roudabush, and Jeff Tindle.

Moved by Roudabush, 2<sup>nd</sup> by Bolen to approve agenda. 3 ayes. Motion carried.

Moved by Bolen, 2<sup>nd</sup> by Roudabush to approve May 29, 2025, board minutes. 3 ayes. Motion carried.

Moved by Roudabush, 2<sup>nd</sup> by Bolen to approve certificate of appointment for Sawyer Tindle, Mechanic, Secondary Road, effective June 16, 2025; rate of pay \$29.87 per hour. Jeff Tindle abstained from voting. 2 ayes. Motion carried.

Brian Paul, Emergency Management Director, discussed the NIMS/NQS Implementation Plan. The purpose of this plan is to provide a strategy on how Poweshiek County will implement the National Incident Management System (NIMS) through the National Qualification System (NQS) and be prepared to respond to and manage the full spectrum of potential incidents, hazards, and impacts, regardless of size, complexity or location. Paul stated he receives federal and state funding through an emergency preparedness grant (EMPG), and part of the grant requirement is to have this plan for disaster response and preparedness. The plan lays out the different roles and responsibilities and who from within the county will fulfill those roles. Individuals filling the needed roles will be required to have education and training in order to operate in that role. Paul will set up department head meetings with county officials to discuss the plan, receive their feedback, and get names of individuals to fill the necessary roles. Before implementation of the plan, the board will need to adopt a resolution.

Lyle Brehm joined the meeting. Brehm anticipates asphalt work will be completed this week on 480<sup>th</sup>, weather permitting. Shoulder rock, rumble strips on the side/center of the road, and pavement markings will still need to be completed. Once completed with asphalt on 480<sup>th</sup>, Manatts will move to continue work on Old 6 Rd east of Hwy 21 into Victor.

Board reviewed the drafted job description for the Assistant Veterans Service Officer. Board requested Auditor to make some revisions and place on agenda for approval at next board meeting. Auditor will then forward to VA Director and VA Commission for their approval.

Moved by Bolen, 2<sup>nd</sup> by Roudabush to approve a letter to Governor Reynolds asking her to line-item veto Section 42 of SF659. 3 ayes. Motion carried.

Bolen is attending Grinnell Food Coalition meeting on Wednesday.

Moved by Bolen, 2<sup>nd</sup> by Roudabush at 10:54 a.m. to adjourn.
