Tylor Nelson, Conservation Director, met with board for the monthly meeting on the Conservation department.

Moved by Roudabush, 2<sup>nd</sup> by Bolen to approve September 12, 2025, payroll for \$339,364.11. 3 ayes. Motion carried.

Skip Lowe & Ryan Lowe, North Risk Partners, met with board to provide information on the services they offer in property/casualty insurance. Lowe provided information on past and current market trends and provided ideas on how he felt the county could possibly save money on insurance costs. Lowe stated they would like to obtain the county's business but does understand that the county currently has an agent. Board will need to decide if they want to stay with their current agent or make a switch.

Jennifer Anderson, Treasurer, met with board to discuss a request she received to open a satellite driver's license station in Grinnell. Anderson provided information from a couple of other counties that have satellite locations. Anderson stated she is not fully opposed to a satellite location, but does not feel it is financially best for the county. Board stated they would like to see the costs associated with satellite location and the feasibility of locating office space in Grinnell. Anderson stated she would do some more research and follow up with the board at a later meeting.

Moved by Roudabush, 2<sup>nd</sup> by Bolen to approve Urban Renewal Joint Agreement with City of Montezuma. 3 ayes. Motion carried.

Moved by Bolen, 2<sup>nd</sup> by Roudabush to approve Utility Permit #26-02U to Poweshiek Water Association for work in Sections 19 & 30, Sheridan Township. 3 ayes. Motion carried.

Moved by Roudabush, 2<sup>nd</sup> by Bolen to appoint Nicole Brua Behrens to Poweshiek County Board of Health. 3 ayes. Motion carried.

Board needed to act on a matter held under closed session under Iowa Code 21.5(1)(c), "to discuss with counsel matters presently in litigation where its disclosure would be likely to prejudice or disadvantage the position of the governmental body in that litigation", specifically the consideration and adoption of a resolution concerning the pending lawsuit with Hardin County and Central Iowa Juvenile Detention and the approval of the settlement of that lawsuit and the entry of a consent decree with Hardin County. Poweshiek County is an interested party because Poweshiek County is a member of Central Iowa Juvenile Detention Center.

Moved by Bolen, 2<sup>nd</sup> by Roudabush to approve Resolution #2026-13 approving the settlement and entry of consent decree with Hardin County and Central Iowa Juvenile Detention Center. Roudabush-aye; Bolen-aye; Tindle-aye. Motion carried.

## RESOLUTION OF THE POWESHIEK COUNTY BOARD OF SUPERVISORS RESOLUTION No. 2026-13

WHEREAS Poweshiek County is a stakeholder in the Central Iowa Juvenile Detention Center (hereinafter CIJDC), and

WHEREAS the CIJDC is the Respondent in Hardin County Case No. CVCV102247, whereby Hardin County calls into question the validity of prior 28E agreements, and

WHEREAS the outcome of that litigation is uncertain, and Poweshiek County has an interest in the outcome of that litigation, and

WHEREAS the CIJDC Commission has voted 22-5 to approve the attached compromise settlement agreement resolving the litigation, and

WHEREAS the compromise settlement agreement is a compromise between Hardin County and the CIJDC that acknowledges the membership of counties joining the CIJDC through 2012 and also allows the remaining counties to maintain certain benefits that the litigation does not otherwise guarantee, while also allowing the counties joining through 2012 to adopt a new 28E agreement and even vote to allow the remaining counties to regain full membership in the CIJDC, and

WHEREAS the Parties will file with the Court a consent decree memorializing the full terms and conditions of the Parties' compromise settlement agreement following approval of the compromise settlement by a majority of the member counties.

THEREFORE, the Poweshiek County Board of Supervisors hereby approve and adopt the attached compromise agreement and authorize the CIJDC to execute and present to the court a consent decree consistent with the attached compromise settlement.
