Moved by Bolen, 2^{nd} by Tindle to approve the OPOID grant request from Grinnell College for \$792 to purchase Naloxone. 2 ayes. Motion carried.

Matt Maschmann, Sheriff; Joe Meyer, Jail Administrator; and Galyn Nook, IT Director, met with the supervisors to discuss a virtual cloud server system for Zuercher. Zuercher system is a suite of public safety software that integrates various functions for law enforcement, specifically providing tools for computer-aided dispatch, jail management, and records management. This system is relied upon daily for law enforcement and public safety. Currently, this system is operated via servers that are on-site. If a disaster were to occur at the public safety building, it could be days before a new server could be obtained, and all backup data reinstalled. The virtual server would be cloud-based and, in the event of a disaster, could be accessed from any location to keep public safety operations running smoothly. Another benefit of virtual is the decrease in time it takes for updates. Sheriff Maschmann stated there would be an increased cost per year of \$15,000 to upgrade to the virtual server. Sheriff Maschmann stated he felt he could handle this increase from within his budget. Nook stated its IT needs would be to have a strong internet connection. He would like two main providers with backup. He also stated this would need a bandwidth of 50, and the county currently has 250, so there wouldn't be an added expense to add more bandwidth.

Bolen stated she has a Grinnell Food Coalition meeting on Wednesday.
