Kevin Kudart, Montezuma Light & Power Superintendent, met with the board to provide information regarding new transmission lines coming to Iowa. Kudart stated there is a proposal to install more transmission lines in Iowa. He states he knows one will go through Poweshiek County and will run from the substation north of town to Marshalltown. With the increase in developments and data centers, bigger transmission lines to transmit more power are needed. He stated it is all in the bid process currently. Once the bid process is complete, more information will be available as to the locations of the new lines.
