The Poweshiek County Board of Supervisors met in regular session at 8:30 a.m. Members present: Jeff Tindle, Jacki Bolen, and Jason Roudabush.

Moved by Tindle, 2<sup>nd</sup> by Bolen to approve agenda. 3 ayes. Motion carried.

Moved by Bolen, 2<sup>nd</sup> by Tindle to approve Utility Permit #26-11U to ITC Midwest LLC for work in Sections 10 & 11, Deep River Township. 3 ayes. Motion carried.

Moved by Tindle, 2<sup>nd</sup> by Bolen to approve February 19, 2026, board minutes. 3 ayes. Motion carried.

Lora Wyckoff, Recorder, met with board to discuss revisions to proposed FY27 budget.

Tylor Nelson, Conservation Director, met with board to discuss revisions to proposed FY27 budget.

Jennifer Anderson, Treasurer, met with board to discuss revisions to proposed FY27 budget.

Board reviewed and discussed the recommendations from the compensation board for the elected official salaries for FY27. The recommendations were as follows: 3.3% for Auditor, Recorder, Treasurer & Board of Supervisors; 5% for County Attorney; and 6% for Sheriff. Moved by Bolen, 2<sup>nd</sup> by Tindle to approve Resolution #2026-37 to approve the recommendations by the compensation board for elected officials, effective July 1, 2026. Roudabush – aye; Bolen – aye; Tindle – aye. Motion carried.

WHEREAS, the Poweshiek County Compensation Board met on January 5, 2026, and made the following salary recommendations for the following elected officials for the fiscal year beginning July 1, 2026:
