Moved by Bolen, 2nd by Tindle to approve the memorandum of understanding between Poweshiek County and Poweshiek County Emergency Management Commission regarding the use of certain county-titled vehicles. 3 ayes. Motion carried.

Moved by Tindle, 2nd by Bolen to approve a letter to Midway USA Foundation showing county support for Grinnell Sure Shots for a grant request they are applying for. 3 ayes. Motion carried.

Supervisor Roudabush provided applications received for the South Central Iowa Solid Waste recycling grant for consideration. The following applications were received:

- City of Montezuma, \$2,000 for purchase of three round trash receptacles with a dome lid
- City of Deep River, \$600 for city-wide cleanup day
- City of Grinnell, \$1,300 for roadside cleanup
- City of Brooklyn, \$2,500 for city-wide cleanup day
- Montezuma Community Development, \$1,000 for Montezuma Pride Day

After reviewing all applications, it was moved by Bolen, 2nd by Tindle, to approve all applications as submitted and authorize Chairman Roudabush to notify South Central Iowa Solid Waste for disbursement of grant funds. 3 ayes. Motion carried.

Board discussed with Glassgow & Holmes the license agreement between Poweshiek County and Poweshiek County Sportsman Association, permitting the Association to use a designated portion of county property for a shooting range in Malcom Township, located by the landfill. Glassgow & Holmes provided some feedback on the drafted agreement. The Board felt it necessary to have the County Attorney make some changes to the agreement, so it will table consideration of approval until a future board meeting.

Bolen has a Region 6 meeting today and a county safety committee meeting on Wednesday.
