Moved by Bolen, 2nd by Roudabush to approve June 4, 2026 board minutes. 2 ayes. Motion carried.

Moved by Bolen, 2nd by Roudabush to approve ownership update for Pilot Travel Centers alcohol and tobacco license. 2 ayes. Motion carried.

CERTIFICATION (CANVASS) OF PRIMARY ELECTION RESULTS

WHEREAS, the PRIMARY ELECTION was held as prescribed by law on June 2, 2026, and;

WHEREAS, the Board of Supervisors have canvassed the vote of said election in accordance with §43.49 and §50.24 of the Code of Iowa, now therefore;

BE IT HEREBY RESOLVED that we, the undersigned members of the Board of Supervisors of Poweshiek County, Iowa, do hereby certify the following turnout report and results in the Primary Election, held June 2, 2026, and that no obvious clerical errors were identified during the canvass.

One Thousand Eight Hundred Twenty-three (1,823) people voted at the polls on election day.

Three Hundred Eighty-six (386) absentee ballots were accepted for counting.

No provisional ballots were accepted for counting (included in absentee total).

A total of Two Thousand Two Hundred Nine (2,209) people voted.
