The Poweshiek County Board of Supervisors met in regular session at 8:30 a.m. Members present: Jacki Bolen and Jason Roudabush.

Moved by Bolen, 2<sup>nd</sup> by Roudabush to approve the agenda. 2 ayes. Motion carried.

Moved by Bolen, 2<sup>nd</sup> by Roudabush to approve July 9, 2026, board minutes. 2 ayes. Motion carried.

Board reviewed the homestead exemption, military exemption, and disabled veteran exemption applications for the 2026 values payable 2027/2028. These exemptions will total over 4.5 million in lost value to the county's valuation.

Moved by Bolen, 2<sup>nd</sup> by Roudabush, to approve the homestead, military, and disabled veteran applications for 2026 values, payable in 2027/2028. 2 ayes. Motion carried.

Moved by Bolen, 2<sup>nd</sup> by Roudabush, to approve Resolution #2027-1 funding property tax credits & exemptions for 2025 values, payable in 2026/2027. 2 ayes. Motion carried.

FY26 FUNDING PROPERTY TAX CREDITS & EXEMPTIONS

Be it resolved that this 13 day of July 2026 that in accordance with Iowa Code Sections 25B.7, 425, and 426A, Poweshiek County will fund:

100% of the value of the Homestead Tax credit,

100% of the value of the Homestead Tax Exemption,

100% of the value of the Military Service Property Tax Exemption, and

100% of the Elderly & Disabled Tax Credit – including Mobile Home, Special Assessment, and Property credits.

For the Fiscal Year 26-27.
