Moved by Bolen, 2nd by Tindle to approve July 31, 2026 payroll for \$298,106.82. 3 ayes. Motion carried.

The Board received notification from the Farm Service Agency about a change in hours of service for the Poweshiek County Farm Service Agency (FSA). Effective September 1, 2026, the Poweshiek County FSA Office will move to one day a week (Wednesday), by appointment only. Further, as of September 1, 2026, mission-critical files from Poweshiek County FSA will be moved to one of four surrounding counties, either Iowa, Mahaska, Jasper, or Tama. Information on which office will be designated for Poweshiek County files will be forthcoming from FSA. The Board of Supervisors intends to write a letter to FSA representatives expressing concern about this change and how it will negatively impact farmland owners in Poweshiek County.

Board received, via email, an update from Iowa DOT regarding the new 60 mph speed limit, stating that there are still some segments in other counties that have not yet been changed and remain at 55 mph until Iowa DOT can complete a detailed review to determine if they too can be raised to 60 mph. In District 1, there are approximately 26 segments that have not been raised. In Poweshiek County, every primary road has been raised to 60 mph.
