

SET DATE FOR HEARING ON 2021 URBAN RENEWAL PLAN AMENDMENT

The Board of Supervisors of Poweshiek County, Iowa, met on October 11, 2021 at 8:30 a.m., at the Boardroom, County Courthouse, Montezuma, Iowa, for the purpose of setting a date for a public hearing on a proposed amendment to the urban renewal plan for the Poweshiek County Road Improvement Urban Renewal Area. The Chairperson presided and the roll being called, the following members of the Board were present and absent:

The Chairperson announced that an amendment to the urban renewal plan for the Poweshiek County Road Improvement Urban Renewal Area had been prepared related to the use of incremental property tax revenues for improvements to certain streets within the City of Montezuma, and that it was necessary to set a date for a public hearing on the proposed amendment to the urban renewal plan. Accordingly, Supervisor Jason Roudabush moved the adoption of the following resolution entitled "Resolution setting date for a public hearing on 2021 Amendment to the urban renewal plan for the Poweshiek County Road Improvement Urban Renewal Area" and the motion was seconded by Supervisor Diana Dawley. RESOLUTION NO.2022-15

Resolution setting date for a public hearing on 2021 Amendment to the urban renewal plan for the Poweshiek County Road Improvement Urban Renewal Area

WHEREAS, the Board of Supervisors of Poweshiek County (the "County") has established the Poweshiek County Road Improvement Urban Renewal Area (the "Urban Renewal Area") and adopted an urban renewal plan (the "Plan") for the governance of projects and initiatives to be undertaken; and

WHEREAS, Chapter 403 of the Code of Iowa requires that, before a county approves any new urban renewal projects or adds new property to an urban renewal area, a Board of Supervisors must amend the existing urban renewal plan to identify and include those new projects and that new property; and

WHEREAS, the County has entered into an agreement with the City of Montezuma (the "City") in which the County has agreed to use incremental property tax revenues generated in the Urban Renewal Area in an amount not to exceed \$2,500,000 to improve certain streets in the City, and an amendment to the urban renewal plan for the Urban Renewal Area has been prepared which identifies those streets, adds their description to the Urban Renewal Area and describes a new urban renewal project in the Urban Renewal Area related to providing tax increment financing for improvements to those streets; and

WHEREAS, it is necessary that a date be set for a public hearing on that plan amendment;

NOW, THEREFORE, Be It Resolved by the Board of Supervisors of Poweshiek County, Iowa, as follows:

Section 1. This Board will meet at the Boardroom, County Courthouse, Montezuma, Iowa, on November 9, 2021, at 8:45 a.m., at which time and place it will hold a public hearing on the proposed amendment to the Plan for the Urban Renewal Area.

Section 2. The County Auditor shall publish notice of the hearing, the same being in the form attached hereto, which publication shall be made in a legal newspaper of general circulation in Poweshiek County, which publication shall be not less than four (4) nor more than twenty (20) days before the date set for the hearing.

There have been several instances when Bob Wilhelm had been performing maintenance duties at public safety building but when hired, he was not hired to provide maintenance at public safety building.

8:54 a.m. Bob Wilhelm, Maintenance Director joined the meeting.

Board discussed with Wilhelm if he wanted to take on additional responsibilities for maintenance and cleaning at the public safety building. Wilhelm expressed interest but inquired about the pay due to increased responsibilities. Wilhelm also expressed his interest in learning more about the HVAC system at public safety building and would like to be present when the contractor performs maintenance. Board agreed to provide an increase in pay for Wilhelm for the increased maintenance work at the public safety building and county services building with a new rate of \$23.25 per hour. Wilhelm will be responsible for maintenance and cleaning of the courthouse, county services building, engineer office and public safety building.
